ALEYAMMA MATHEW she/her/hers Collective Future Fund

Aleyamma is a nationally known expert on the intersection of gender and economic justice. With over 20 years of experience in the philanthropic and advocacy sectors at the local, state, and national levels, she has led advocacy, grantmaking, capacity-building, and campaigns for economic policies to protect women's rights, safety, and economic security, with a focus on women of color, immigrant and

refugee women, and low-wage women workers. Aleyamma is currently the executive director of Collective Future Fund (CFF), an organization that brings together social justice movements, survivors, and donors to heal, resource, and mobilize to shape a collective future free from sexual harassment and violence. With a priority on supporting and sustaining efforts that are led by survivors and women of color, the Fund envisions a world in which all women and girls—cisgender, transgender, and gender non-conforming—can live, learn, and work in safety and dignity. Born in Kerala, South India, Aleyamma is based in Philadelphia where she serves on the Board of Directors for the Asian Arts Initiative. She is an alumni of the East West Center in Honolulu and is a Distinguished Lecturer at the Center.

### **AMORETTA MORRIS**

Amoretta is President of Borealis Philanthropy. She came to Borealis from the Annie E. Casey Foundation, where she served as Director of National Community Strategies. Throughout her career, Amoretta has devoted herself to social change. She brings a range of critical perspectives and experiences to philanthropy—as an organizer, grantee, board member, staff member, and donor. Amoretta has more than a decade of experience



shaping policies and programs to improve the lives of youth and families. She has moved between the nonprofit and government sectors, either organizing for social change from the outside or reforming institutions from the inside. She brings deep experience in education policy, youth development, civic engagement, interagency collaboration and nonprofit management. Amoretta is on the boards of Neighborhood Funders Group, where she is co-chair, and the Black Swan Academy. She is a member of the Black Benefactors Giving Circle in Washington, D.C., and is a lay leader at Unity of Washington, D.C.



ANA CONNER they/them, she/her Third Wave Fund

Ana is a Co-Director of Third Wave Fund, an activist fund led by and for women of color, intersex, queer, and trans folks under the age of 35 in the US. Third Wave ensures that communities of color and low-income communities have the tools they need to lead powerful movements, and that they have a seat at the table within philanthropy. Ana came to this work through organizing with FIERCE, where they convened queer and

trans youth of color across the US to talk about gentrification, policing, and how young people are building a movement to end violence. They became passionate about resourcing organizations and movements that are most affected by oppression while participating in the Miss Major Jay Toole Giving Circle. Before Third Wave Fund, they were at Borealis Philanthropy, supporting the Transforming Movements Fund and Black-led Movement Fund. Their first entry into philanthropy was as a development team member at the Astraea Lesbian Foundation for Justice. They currently sit on the board of the Transgender Law Center and Astraea Foundation. Ana received a B.A. from New York University in Gender & Sexuality Studies and American Studies.

### **CARLA FREDERICKS**

Carla joined The Christensen Fund in January, 2021 as Executive Director. She is a seasoned leader in sustainable economic development, human rights, business and finance, Indigenous Peoples law, and federal Indian law. Her core work has focused on realization of Indigenous Peoples human rights. She has served in several capacities, including providing core support to the UN Special Rapporteur on Rights of Indigenous



Peoples, serving as of counsel to the Standing Rock Sioux Tribe in their opposition to the Dakota Access Pipeline, assisting the Maya peoples of Southern Belize in implementing the affirmation of their land rights, and developing a model for Indigenous-driven consent processes and remedy. As a faculty member of the University of Colorado Law School, Carla reconstituted First Peoples Worldwide in 2017 to promote implementation of Indigenous rights consonant with the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP). She has deep experience as an expert and innovator in the fields of finance and human rights through First Peoples Worldwide and the Investors & Indigenous Peoples Working Group. She has authored and co-authored numerous studies and papers for various law reviews and policy journals. Carla is a graduate of the University of Colorado and Columbia Law School. She is Chair of the Board of Trustees for the Mashantucket Pequot (Western) Endowment Trust, and is a member of the Indigenous Peoples Advisory Group to the Decolonizing Wealth Project. She is a proud, enrolled citizen of the Mandan, Hidatsa, and Arikara Nation of North Dakota.

Craig is Co-Executive Officer of Victoria Foundation. For the past 15 years, he has served in several roles at the Victoria Foundation. Born and raised in Newark, New Jersey, Craig's career includes stints with the federal government, the private sector, and for the past 20 years with non-profit and philanthropic organizations. Prior to joining Victoria Foundation, he started his nonprofit and philanthropic career working

with neighborhood residents to build their community organizing and planning skills. He worked for five years as a community organizer in the city of Newark where he worked with and learned from residents how to address various power structures and hold them accountable. After this, Craig entered philanthropy and managed the Neighborhood Leadership Initiative at the Community Foundation of NJ. Craig serves on a number of non-profit boards including Greater Newark LISC, YouthBuild-Newark, LEAD Charter School, Council of NJ Grantmakers, and the Wells Fargo Regional Foundation. He holds a B.S. in Finance and a M.B.A. in management.

Jennifer is a passionate advocate for social justice with a deep breadth of experience as a lawyer, non-profit leader, teacher and organizer. North Star Fund, where she has been the Executive Director since 2017, supports grassroots organizing led by communities of color building power in New York City and the Hudson Valley. Community organizers award North Star Fund's grants, and the fund mobilizes people across



race and class to give to work that centers systems change. Before she came to North Star Fund, Jennifer practiced law for almost 20 years. She led Queens Legal Services, a community-based legal advocacy center. Previously, she was the Director of New York Appleseed, a public interest policy center. As a litigation associate at Paul Weiss LLP, Jennifer worked on a team that represented 13 Guantánamo Bay prisoners held after 9/11. She litigated post-9/11 civil rights, criminal justice and immigrants' rights issues in partnership with organizing movements as a Gibbons Fellow in Public Interest Law and Constitutional Litigation and Skadden Fellow at the ACLU-NJ. Jennifer has worked for the City of New York as an Urban Fellow and has taught at Rutgers University and Rutgers School of Law. She trained as a community organizer with immigrant workers centers in Oakland, Boston and New York's Chinatowns. She has also been an office temp and worker in sales, retail and food services. Jennifer was raised in New Jersey by her immigrant parents, attended Harvard University and NYU School of Law, and lives in Brooklyn with her partner and two children.

Rowe Price from Quidoo, an international consulting firm he started and led for over a decade, merging the firm in 2015. John served as a management and social policy professor for over a decade at NYU and Rutgers and served as a Visiting Scholar at the Hauser Center at Harvard. He is currently

serving as an Honorary Professor of Practice at Queen's University in Northern Ireland and has worked with the China Global Philanthropy Institute in Beijing. John received an MPA from New York University, an MBA from American University and a doctorate from Northeastern University. He has been a writer with Forbes, the Stanford Social Innovation Review, Nonprofit Quarterly and the Huffington Post and is an author of several books. John has spoken to thousands on third sector and social-safety net effectiveness and public-private partnerships, in all fifty states and in nearly forty countries. He began his work serving in the local community, inspired by growing up in deep poverty, serving as a community organizer and family case manager in urban neighborhoods in the Midwest to leadership positions, including CEO, with local and national organizations on the East Coast. John is proud that this work leaves a legacy of innovative efforts that still serves every day a wide network of children and families, including homeless women and children receiving emergency services in Northern Virginia, to after-school programs for children in the housing projects in South Brooklyn to transitional housing options for immigrant families in Boston who are suffering from domestic violence.

## LISA OWENS she/her/hers Hyams Foundation

Lisa joined the Hyams Foundation in January 2021 and brings more than 25 years of experience in building local grassroots organizations and national movements for social, racial, and economic justice. She began organizing in the mid 1980s as a young person in the Roxbury based group, Free My People, fighting against systemic racism in the police department and in the schools. Since then, she has maintained her

commitment to Black liberation and grassroots power building in communities of color. She previously served as the Executive Director of City Life/Vida Urbana, a prominent housing justice base building group that is nationally recognized for organizing working class communities of color against displacement and building collective power for systemic change. Prior to that, she was the Executive Director of mytown, a nationally recognized youth development organization. Lisa brings to Hyams extensive experience as an educator, a trainer and a coach of community based nonprofit leaders and organizations. For the past 15 years, she's taught courses on community organizing and nonprofit management at Boston University and Springfield College. Molly is the Executive Director of the Butler Family Fund, whose mission is to seek lasting solutions to homelessness and an equitable criminal legal system. She also manages a consulting practice rooted in her personal and professional commitment to social justice. Molly works closely with individual donors and family foundations, providing strategic guidance on expanding grantmaking programs, developing



participatory grantmaking models, governance assessment and redesign, and organizational development. Before joining the Butler Family Fund, Molly served as the Associate Director of the Philanthropy team at TCC Group, a mission-driven consulting firm and certified B Corp. Molly also served as the Assistant Director of the Unitarian Universalist Veatch Program at Shelter Rock, a national social justice grantmaker. Molly serves on the Board of Directors of the National Committee for Responsive Philanthropy (NCRP) and was a competitively selected member of their *Power Moves* Consultant Learning Cohort. She is a past co-chair of the Board of Directors of Neighborhood Funders Group and was honored to receive their 2018 *Award for Excellence in Philanthropy*. Molly is also a co-founder and co-chair of Funders for Justice, a national network of funders committed to increasing resources to grassroots organizations addressing the intersection of racial justice, gender justice, community safety, and policing. Molly has a Master of Public Administration with a specialization in International Nonprofit Management from New York University's Robert F. Wagner Graduate School of Public Service and a bachelor's degree in Anthropology and Literature from Antioch College in Ohio. NICOLE PITTMAN she/her/hers Just Beginnings Collaborative

Nicole is a visionary and compassionate thought-leader in ending child sexual abuse with 23 years of experience as a lawyer, social justice policy advocate, and activist. In the course of creating national initiatives like the Center for Youth Registration Reform (CYRR) at Impact Justice, writing a Human Rights Watch report, and transforming laws at the state and federal levels, she saw firsthand that our country's existing "solutions"

are merely after-the-fact responses to harm. Grounded in the lineage of anti-violence feminist work led by women of color, Nicole looks upstream toward the root causes of child sexual abuse. Her devotion to centering survivor stories from the "margins" aligns both with the spirit of Just Beginnings Collaborative's genesis and coming evolution. As Executive Director, Nicole advances JBC's position as a funding intermediary using philanthropic activism to help foundations figure out what it means to accompany and amplify survivor-led, non-punitive solutions to ending childhood sexual harm. Among these are BIPOC, queer and trans, undocumented, and formerly incarcerated individuals from whom institutional responses pose a threat and not a road to repair. Ultimately, JBC seeks to weave the issue of ending child sexual abuse into the broader tapestry of anti-violence and social justice movements. Nicole served as Vice President and Director of the Center on Youth Registration Reform. Before that, she worked as a juvenile justice policy analyst attorney at the Defender Association of Philadelphia. She was also an attorney at the Juvenile Justice Project of Louisiana, the New Orleans Public Defender Office, and the New Orleans Pro Bono Project. She received a J.D. from Tulane Law School and a B.A. from Duke University.

Philip leads the Robert Sterling Clark Foundation, which is working to create a more equitable and vibrant New York City by investing in her people. The foundation supports individuals, the organizations that develop them and the networks of which they are a part. With only 1% of philanthropic dollars earmarked for the people doing the work in communities, the foundation believes committing resources in this way



is one of the most effective ways to bring about change. Previously, Phil was Chief Operating Officer at both The Century Foundation, a progressive public policy think tank, and at the Brooklyn Community Foundation, which he helped launch by converting it from a corporate entity. Earlier he was a Senior Managing Director at Changing Our World, a consultancy supporting nonprofits. Phil served as Executive Director of the Coro New York Leadership Center for four years after being a participant in its Leadership New York program. That experience prompted him to jump to the nonprofit sector from Wall Street, where he spent the first-half of his career, beginning as an analyst at Merrill Lynch and finishing it rating junk bonds at Moody's. Phil is Co-chair of the Leadership Funders Group and a member of the Steering Committee of the Trust-Based Philanthropy Project. He serves on the boards of Grantmakers for Effective Organizations, United Philanthropy Forum, and two family foundations, and is a past board chair of Philanthropy New York, the regional association of grantmakers in the city. Phil has a BA in Biology and Economics from the University of Pennsylvania and an MBA in Finance and Strategic Planning from The Wharton School. He calls Brooklyn, New York home.




VIVEKA CHEN she/they Consultant and Facilitator


MICHELLE GISLASON she/her/hers Consultant and Facilitator
