### WE DO THIS BY:

Featuring racial justice prominently in our problem statement, vision, activities, outcomes, values, and practicing racial justice in the operations of the fund.

Genuinely relinquishing power to local and BIPOC community leaders. For example, Western Pennsylvania's co-created grantmaking strategy was developed by Local Strategy Advisors, and was used by Amplify staff to select grantees. Additionally, the design of the second phase of Amplify's work (planned to launch in 2023) is being led entirely by grantees, including grantees in Western Pennsylvania.

Finally, Amplify funders are committed to organizing within their institutions and the broader field of philanthropy in service of doing what works for grantees.

This includes general operating grants and additional grants such as COVID, wellness, capacity building, collaboration, and Future of Amplify design.

**SUPPORT FOR GRANTEE-LED COLLABORATIONS:**

- Collaboration between Pittsburgh United and APA to strengthen the movement ecosystem in Western Pennsylvania, and continue to build a pipeline of BIPOC and frontline leaders who are ready to participate in trainings, take advantage of leadership development opportunities, and build a shared language.
- Collaboration between 1Hood Media, the Abolitionist Law Center, and APA to support the Coalition to Reimagine Public Safety, an initiative creating a community-led approach to public safety by creating models of intervention and prevention that reduce incarceration and police contact in Black and Brown communities throughout Allegheny County.



In 2019, Local Strategy Advisors in Western Pennsylvania highlighted four conditions necessary to build power that have guided Amplify's grantmaking:

1. Community organizing
2. Collaboration
3. Capacity-building for BIPOC-led organizations
4. A leadership development pipeline for BIPOC leaders
